The investment objectives are to achieve positive returns and a Sharpe ratio higher than the Stoxx 600 with a volatility of returns lower than the Stoxx 600. The company varies its equity exposure at its discretion, investing the balance in money market instruments.

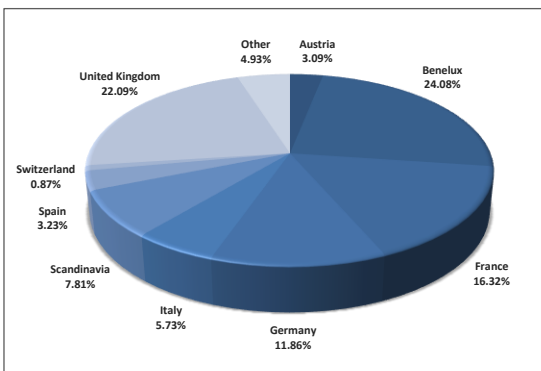

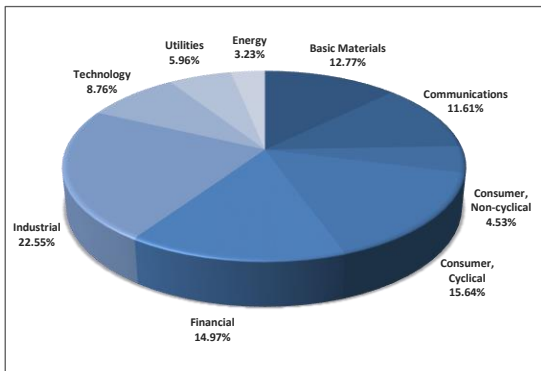

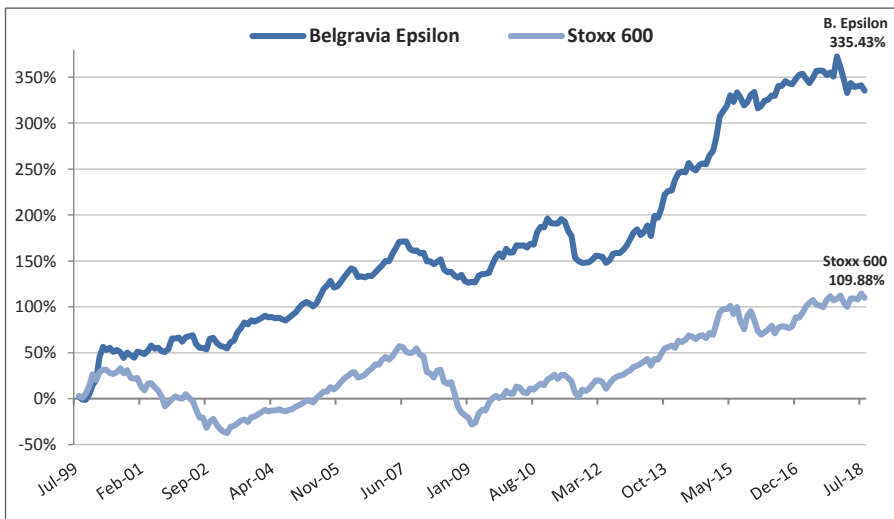
GEOGRAPHICAL ALLOCATION

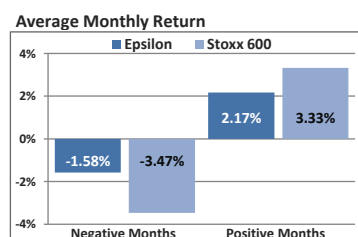

PORTFOLIO MANAGER COMMENTS

In August Belgravia Epsilon dropped by 1.28% with an average beta of 0.11 against the Stoxx 600, which fell by 2.14%. European equities corrected on increased tariff risks from the USA and extended financial pressure on emerging markets.

In August Belgravia Epsilon had a negative performance, due both to systematic risk (though low) and negative stock picking contribution. Best gains came from Mips, Royal Caribbean, Scor, TI Fluid, Siemens Gamesa and SGL Carbon.

As of the 31st of August, Belgravia Epsilon had a net equity exposure of 27% and a beta of 0.09 against the Stoxx 600.
