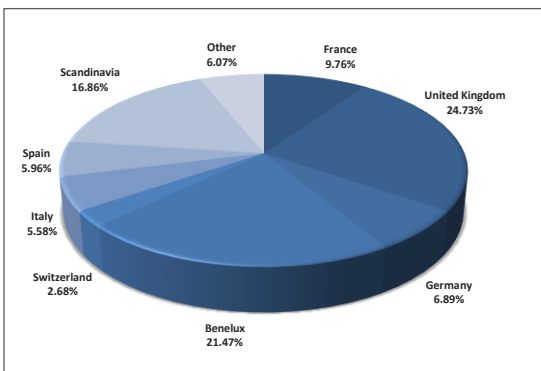

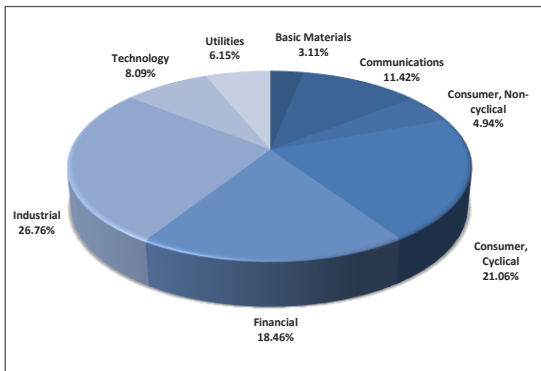

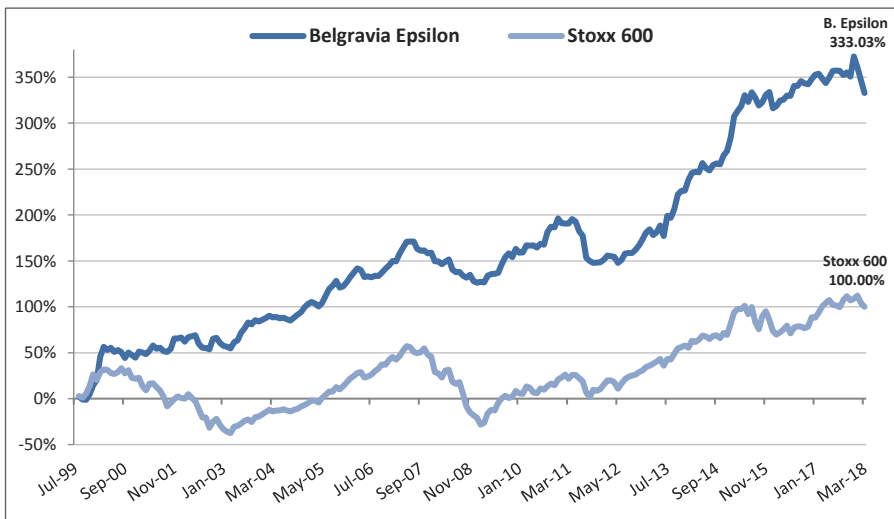
## GEOGRAPHICAL ALLOCATION

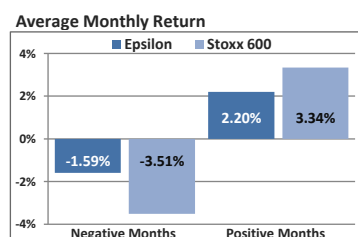

## PORTFOLIO MANAGER COMMENTS

In March Belgravia Epsilon fell by 3% with an average beta of 0.51 against the Stoxx 600, which fell by 2%. European equities fell further, dragged by US tariff proposals and the outcome of Italian elections.

In March Belgravia Epsilon had a bad performance due to both the market correction and negative stock picking contribution. Best gains came from Prudential, SMS and Befesa.

As of the 31st of March, Belgravia Epsilon had a net equity exposure of 65% and a beta of 0.48 against the Stoxx 600.
