The investment objectives are to achieve positive returns and a Sharpe ratio higher than the Stoxx 600 with a volatility of returns lower than the Stoxx 600. The company varies its equity exposure at its discretion, investing the balance in money market instruments.

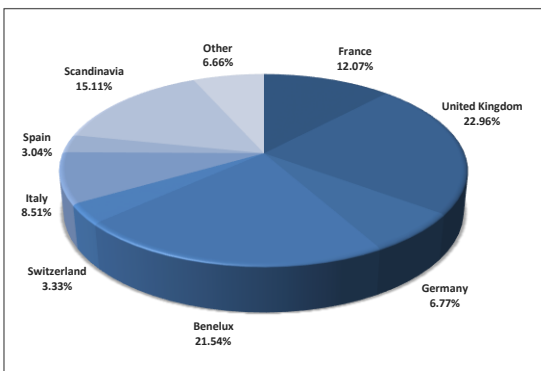

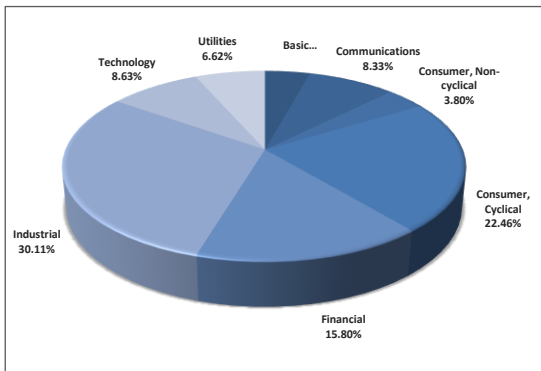

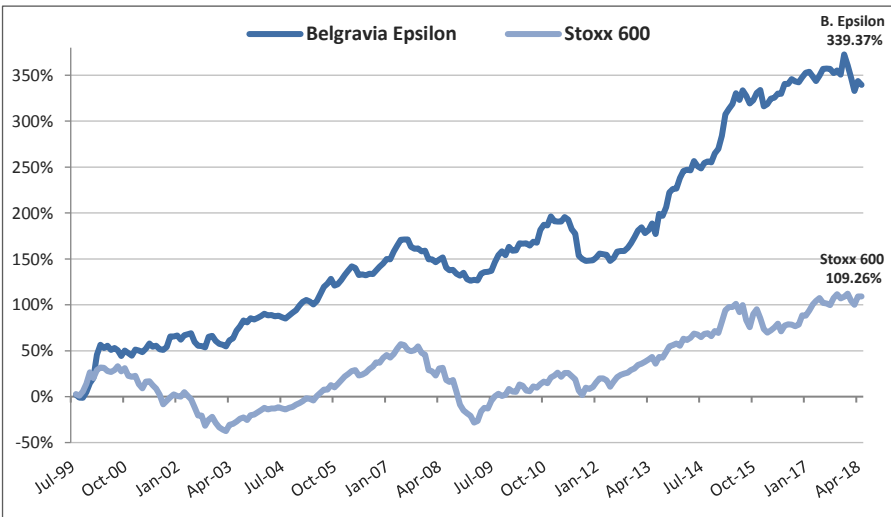
GEOGRAPHICAL ALLOCATION

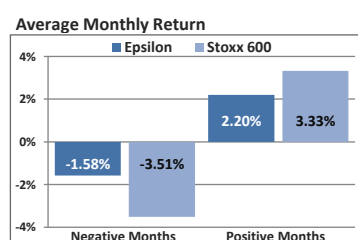

PORTFOLIO MANAGER COMMENTS

In May Belgravia Epsilon dropped by 0.97% with an average beta of 0.46 against the Stoxx 600, which returned 0.13%. European equities recovered gradually but ended flat in the month, as political risks rose suddenly in North Korea, Italy and Spain.

In May Belgravia Epsilon had a negative performance due to the correction suffered in the last week. Best gains came from materials (Solvay, Clean Teq and AMG) and, individually, Mips, SMS and Strix. In the quarter to date, the performance has been positive due to both market return and stock picking, after a disappointing first quarter.

As of the 31st of May, Belgravia Epsilon had a net equity exposure of 59% and a beta of 0.48 against the Stoxx 600.
