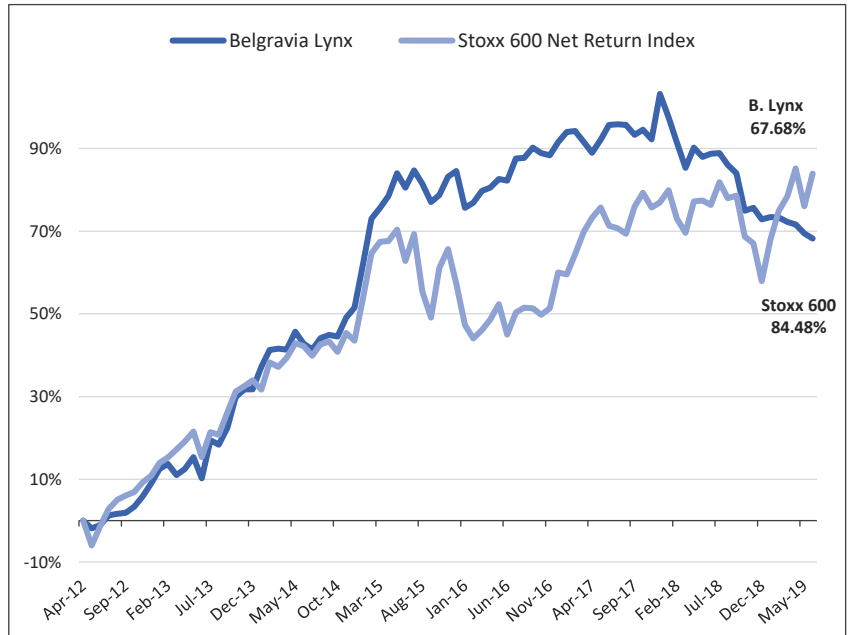
## INVESTMENT POLICY
