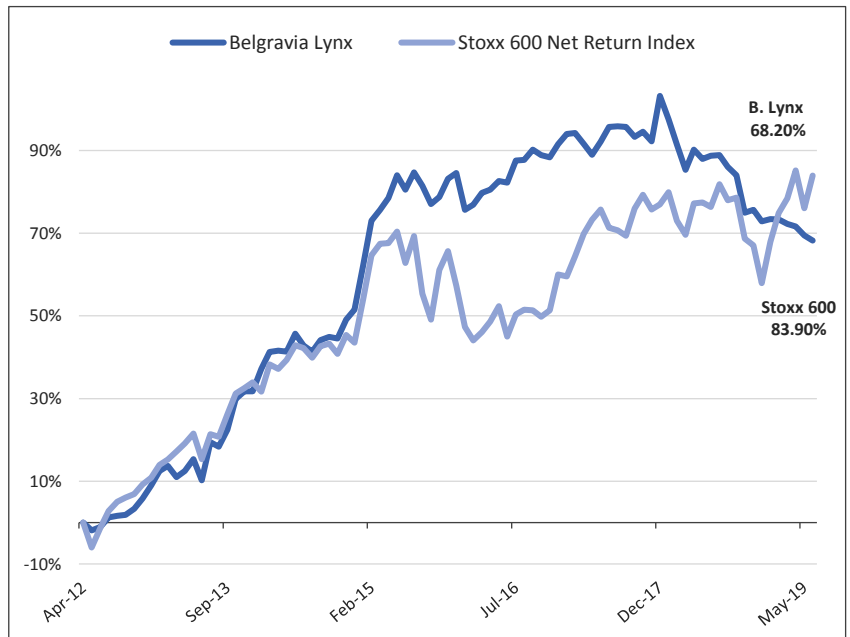
INVESTMENT POLICY
