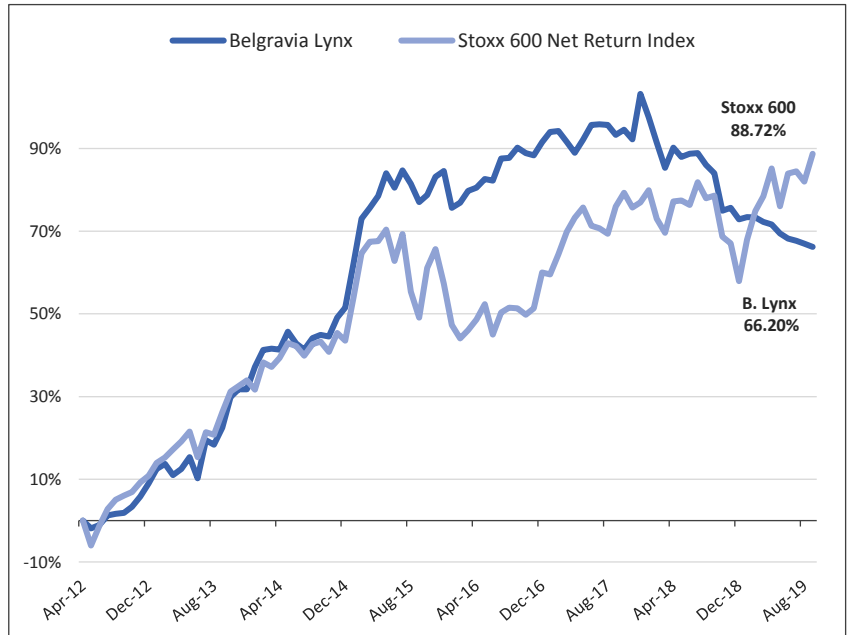
INVESTMENT POLICY
